Payment Conditions – IATS Conference 2026

On behalf of the IATS Organizers 2026, all conference-related payments will be made to One Globe Travels & Tours Pvt. Ltd. (OGTC). All payments are processed in United States Dollars (USD).

1. Payment Method (Bank Transfer or Credit Card Payment)

3. Hotel Payments
